# Fire Station 34 Update and Progress

Chief O'Brian narrated a video showing construction progress at Station 34. Occupancy is estimated during the second week in August. He stated that the project continues to be on time for completion and within budget. Over the next couple of weeks, the finishing details will move quickly. Deputy Chief Evans has been on site daily working with the architect and contractor as we finalize many of the details.

Major updates include:

Window are installed in portions of the south side addition
Drywall work will begin this week
Rough mechanical, electrical and plumbing is complete
Concrete apron and 3/4 of the training pad are complete
Final flooring in apparatus bay to be complete after the 4th of July
Exterior metal and flashing to begin installation the third week of July

#### Good of the Order

Chief O'Brian reported the push is underway to hiring more Paid-on-Call firefighters.

BAFA was awarded a support grant of \$7,700 from FEMA to assist with face coverings and masks during the pandemic. Chief O'Brian estimated the actual expenses incurred in response to the pandemic to be between \$60-70,000.

Both fire academies will soon be finalized. The Howell High School program has 17 graduates and Livingston County has 15 graduates. Chief O'Brian recognized the efforts of Lieutenant Kiurski and Training Chief Mowbray to complete these programs with classroom constraints due to Covid-19. He added that both academies will start up again in August.

Chief O'Brian reported that the incident numbers are up and we are still responding to Covid-19 calls. He also mentioned that the number of suicides has increased.
